U.S. and International Litigation Services

In addition to its diverse U.S. domestic litigation practice, commercial litigation, securities fraud, legal malpractice, and insurance defense cases, the firm has conducted litigation and arbitrations in Cyprus, England, Russia, Sweden, Switzerland, and other countries. In 1999, the firm's founder and managing director, Bruce Marks, represented a Russian industrial company, which filed claims in New Jersey to recover \$150 million that was improperly diverted in a trade fraud scheme. In 2002, Marks filed a \$2.7 billion suit in New York on behalf of the foreign trading partners of a Russian aluminum factory whose contracts were abrogated in sham bankruptcy proceedings. In 2001, Marks & Sokolov brought claims in Colorado in excess of \$3.6 billion against Russia's largest oil company for wrongdoing related to the denial of rights to develop one of the world's richest diamond fields. In 2002, the firm brought a \$1.5 billion suit in New York against US-based entities engaged in a massive racketeering scheme to take over a substantial portion of the Russian oil industry. In 2004, the firm filed claims in Delaware in excess of \$1 billion related to the illegal seizure of a Russian vanadium plant. In 2005, the firm obtained freezing orders in Cyprus and the Commercial Court in England in a dispute over control of Ukrainian electricity distribution companies. In 2006, the firm filed suit in Massachusetts to recover \$1 billion in profits diverted from a Ukrainian ferroalloy plant.

The firm's most recent litigation successes in 2005 include a ground-breaking decision in the Second Circuit Court of Appeals in New York establishing that Russia was an inadequate forum for litigating a dispute related to the illegal seizure of a Russian oil company and a landmark decision of the Colorado Supreme Court reversing a lower court's decision dismissing a claim against Russia's largest oil company for lack of personal jurisdiction.
